HERTFORDSHIRE COUNTY COUNCIL

TOWN AND COUNTRY PLANNING ACT 1971—SECTION 277

*Designation of a Conservation Area
Aston, Hertfordshire*

Notice is hereby given that the Hertfordshire County Council in accordance with section 277 (2) of the Town and Country Planning Act 1971, as amended by the Town and Country Amenities Act 1974, by resolution have designated a Conservation Area at Aston, Hertfordshire. The area includes Aston Dene, St. Mary's Church and Park Farm, with the open land between. It extends, eastward along Benington Road to include the Post Office and Pig and Whistle PH and the part of Brookfield Lane immediately to the north; northward along Aston End Road to include No. 8 on the east side and No. 31 on the west side, and along Dene Lane to include The Lodge; westward along Broadwater Lane to a point in line with the western boundary of the grounds of Gregor House; and southward

along Stringers Lane to include Astonbury Farm Cottages. A plan showing the boundary of the designated Conservation Area may be inspected at the County Planning Department, County Hall, Hertford, at the office of East Hertfordshire District Council at "Wallfields", Pegs Lane, Hertford and at the office of Stevenage Borough Council, Manulife House, St. George's Way, Stevenage.

Permission must be obtained from the Local Planning Authority to demolish or partially demolish any building within a Conservation Area. Anyone proposing to fell or lop trees in a Conservation Area must give the Local Planning Authority 6 weeks notice of their intention. There are penalties for contravention of these requirements. Anyone requiring further information concerning the effects of designation should contact their Local Planning Authority, or the County Planning Officer at the above address.

NOTICE OF PUBLIC PATH ORDER

*North Kesteven District (Metheringham No. 11) Public
Path Diversion Order 1979*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 24th January 1979, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the North Kesteven District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert that part of the public footpath running north-eastwards from the south-eastern end of Grange Road, Metheringham for a distance of 200 metres to a point on the north-eastern boundary of O.S. 3258 adjoining the railway line to a line south-east of the present line of the path running north-eastwards from a similar point in Grange Road to a similar point on the north-eastern boundary of O.S. 3258.
