*The Nottinghamshire County Council (Goose Gate Area, Central Core, Nottingham) (Experimental Amendment) (No. 1) Order 1979.*

Notice is hereby given that the Nottinghamshire County Council proposes to make an Order under section 9 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

Waiting by vehicles will be limited to 30 minutes, no return within the following 30 minutes, between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the following lengths of road in the City of Nottingham:

- (i) *Brightmoor Street*, east side, from a point 10 metres (33 feet) south of its junction with Cranbrook Street for a distance of 27 metres (89 feet) in a southerly direction and from a point 10 metres (33 feet) north of its junction with Goose Gate for a distance of 10 metres (33 feet) in a northerly direction.
- (ii) *Broad Street*, west side, from a point 17 metres (56 feet) south of the centre line of Old Lenton Street for a distance of 40 metres (131 feet) in a southerly direction.
- (iii) *George Street*, east side, from a point 14 metres (45 feet) north of its junction with Carlton Street for a distance of 17 metres (56 feet) in a northerly direction.
- (iv) *George Street*, west side, from a point opposite the centre line of Old Lenton Street for a distance of 33 metres (108 feet) in a southerly direction.

The usual exemptions will be provided.

*The Nottinghamshire County Council (A.60, Nottingham Road, Atkins Lane, Mansfield) (Prohibition of Waiting) Order 1979.*
