

The effect of the Orders, if confirmed without modifications will be—in respect of (A) above—to extinguish the public right of way running from a point approximately 268 metres north-north-east of the junction of the existing path and Harbury Lane in a north-north-easterly direction for 277 metres to a point 66 metres north-north-west of the southern end of Chandlers Road, Whitnash; the Warwick District Council is satisfied that an alternative right of way is not required: in respect of (B) above—to divert the public right of way running from a point approximately 329 metres north-north-east of the junction of the existing path and Harbury Lane (for the first 46 metres running between Nos. 139 and 141 Landor Road) north-eastwards for 82 metres, and then north-westwards for 74 metres to the southern end of Washbourne Road, to a line running from a point being approximately 329 metres north-north-east of the junction of the existing path and Harbury Lane situated to the front of the south-western boundaries of Nos. 139-141 Landor Road, commencing on part of the highway Landor Road running south-eastwards for 75 metres then parallel with the boundary of the public open space and within the public open space, north-east for 7 metres, eastwards for 80 metres, then parallel with the eastern and southern boundaries of the public open space for

215 metres, westwards for 140 metres, passing the southern end of Chandlers Road, to Washbourne Road.

A copy of the Orders and the maps contained in them have been deposited and may be inspected free of charge at the office of the Secretary and Solicitor, Warwick District Council, Town Hall, Leamington Spa, Monday to Friday inclusive during normal office hours.

Any representation or objection with respect to the Orders may be sent in writing to the Secretary and Solicitor, Warwick District Council, Town Hall, Leamington Spa, before 19th March 1979 and should state the grounds on which it is made.

If no representations or objections are duly made or if any so made are withdrawn, the Warwick District Council may instead of submitting the Orders to the Secretary of State for the Environment for confirmation, themselves confirm the Orders as unopposed Orders.

If the Orders are submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be submitted with the Orders.
