### PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 6th February 1979 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

- 1. Declaring redundant the church of Saint Mary Magdalene, Langthorne, a chapel of ease in the parish of Crakehall, in the diocese of Ripon.
- 2.—(1) Uniting the benefices of Christ Church, Stafford; Saint Mary and Saint Chad, Stafford; and Marston with
- (2) Uniting the parishes of Christ Church, Stafford; Saint Mary and Saint Chad, Stafford; Marston; and Whitgreave;
- (3) Incorporation the extra-parochial places known as Tillington; and Yarlet in the new parish;
- (4) Altering the areas of the new parish;
  (4) Altering the areas of the new parish and the parishes
  of Saint James, Salt; Saint John, Stafford; Saint Thomas,
  Castle Town; and Seighford with Derrington and Creswell;
  (5) Declaring redundant the parish church of the parish
- of Christ Church, Stafford; and
  (6) Establishing a team ministry for the area of the new benefice, in the diocese of Lichfield.

- 3. Declaring redundant the parish church of the parish of Haley Hill, in the diocese of Wakefield.
- 4. Uniting the benefices and parishes of Saint Matthew, Darlington; and Saint Luke, Darlington, in the diocese of Durham.
- 5. Uniting the benefices of Surfleet and West Pinchbeck, in the diocese of Lincoln.
- 6. Uniting the benefices of Northam and Appledore, in the diocese of Exeter; establishing a team ministry for the area of the new benefice and altering the name of the parish of Northam.
- 7. Amending an earlier Scheme providing for the establishment of a team Ministry for the area of the benefice of Banbury, in the diocese of Oxford.
- 8. Establishing a team ministry for the area of the benefice of West Derby, in the diocese of Liverpool.
- 9. Uniting the benefices and parishes of Saint Peter, Upper Holloway and Saint John, Upper Holloway, in the diocese of London.
- 10. Creating a new benefice and parish of Canley and altering the areas of the parishes of Stivichall; Saint Barbara, Earlsdon; Holy Trinity Coventry; Westwood; and Saint Nicholas, Kenilworth, in the diocese of Coventry.
- 11. Vesting part of the churchyard of the parish church of the parish of Wistow, in the diocese of Ely, in the Ely Diocesan Board of Finance Limited for disposal.
- 12. Uniting the benefices of Kingsdown, Saint John the Evangelist; and Ringwould with Oxney, in the diocese of Canterbury.
- 13. Uniting the benefices of Bishop Burton, and Walkington, in the diocese of York.
- 14. Uniting the benefices of Hampton Lucy with Charlecote; and Loxley, in the diocese of Coventry.
- 15. Uniting the benefices of Pakenham; and Norton with Tostock, in the diocese of Saint Edmundsbury and Ipswich.
- 16. Appropriating the redundant church Catherine, Dodington, a former chapel of ease in the parish of Whitchurch, in the diocese of Lichfield, and the land annexed or belonging thereto, to use for the repair, restoration and manufacture of clocks and for purposes ancillary thereto and empowering the said Commissioners to sell the said building and land for such uses.
