And the applicants by their counsel undertaking within one month of the restoration of the name of the company to the register of companies to forward to the Registrar of Companies as required by sections 124 and 126 of the Companies Act 1948 a copy of the annual return of the company for each of the years 1975 to 1977 inclusive and to give to the Registrar of Companies as required by section 23 of the Companies Act 1976 notices in the prescribed form of any change in the situation of the registered office of the company and to deliver to the Registrar of Companies as required by section 52 of the Companies Act 1948 a return of allotments in the prescribed form

And the applicant Cecil Julian Bendall by his counsel undertaking within one month of the restoration of the name of the company to the register of companies to deliver to the Registrar of Companies as required by sections 1 and 6 of the Companies Act 1976 a copy of every document required by the said section 1 to be comprised in the accounts of the company

It is ordered that the name of the above-named C. J. Bendall Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the Companies Act 1948 the said C. J. Bendall Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the applicants the said C. J. Bendall Limited and Cecil Julian Bendall do pay to the Registrar of Companies his costs of the said application such costs to be taxed on the Common Fund basis if not agreed
