## MAIDSTONE BOROUGH COUNCIL

*The Borough of Maidstone (Off-Street Parking Places) (Variation No. ) Order 1979*

Notice is hereby given that the Maidstone Borough Council propose to make an Order under section 31 (1) and 84D (1) of the Road Traffic Regulation Act 1967, as amended.

The effect of the proposed Order would be to amend further the Maidstone (Off-Street Parking Places) Order 1962 so as to:

- (1) Apply the following revised scale of charges between the hours of 8 a.m. and 6.30 p.m. Monday to Saturday inclusive:

*Inner Zone Car Parks*

For any one visit, 10p per hour or part thereof (50 per cent. of this charge for vehicles having not more than two wheels at the King Street and Medway Street multi-storey car parks).

*Outer Zone Car Parks*

For any one visit, 10p per two hours or part thereof. (No charge for vehicles having not more than two wheels).

*Perimeter Zone Car Parks*

For any one visit, 5p per two hours or part thereof. (No charge for vehicles having not more than two wheels).

*Season Ticket Rates*

For twelve weeks (6 day availability) £40.82 (inclusive of V.A.T.).

For twelve weeks (5 day availability) £34.02 (inclusive of V.A.T.).

*Penalty and Excess Charges (Pay and Display System)*

Penalty Charge, £5.

Excess Charge, £1.

- (2) Revise the existing Zoning scheme so far as the under-mentioned car parks are concerned:

*Mill Street Car Park*, from Outer Zone to Inner Zone.

*Bridge Wharf Car Park*, from Perimeter Zone to Outer Zone.

*Mote Road Car Park*, from Perimeter Zone to Outer Zone.

## GREATER MANCHESTER COUNTY COUNCIL

*The Greater Manchester County (Foundry Street, Bury) (Restriction of Waiting) (County) Order 1978*

Notice is hereby given that on 1st February 1979, the Greater Manchester County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit waiting between the hours of 8 a.m. and 6 p.m. on Monday to Saturday inclusive on the following length of street:

*Foundry Street*, both sides, from Rochdale Road to a point 10 metres south of the southerly kerbline of Back Rochdale Road South.

The Order contains exemptions to permit waiting for the purpose of boarding or alighting, loading and unloading, building operations and work on or under the length of road. Disabled person's vehicles displaying the relevant disabled person's badge may wait for up to two hours return prohibited within one hour.

A copy of the Order which comes into operation on 12th February 1979, and a map showing the road to which it relates may be inspected between 9 a.m. and 4.30 p.m. on Mondays to Fridays at:

(a) The County Secretary's Office, County Hall, (Mins-hull Street entrance), Piccadilly Gardens, Manchester; or

(b) The Director of Administration's Office, Bury Borough Council, Town Hall, Bury.

Any person who wishes to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks from 1st February 1979 apply to the High Court for this purpose.

## GREATER MANCHESTER COUNTY COUNCIL

*The Greater Manchester County (Back Manchester Road and Back Tenterden Street, Bury) (Prohibition of Waiting) (County) Order 1978.*

Notice is hereby given that on 1st February 1979, the Greater Manchester County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit waiting at any time on:

*Back Manchester Road*, both sides, from the southerly kerbline of St. Mary's Place for a distance of 50 metres in a southerly direction.

*Back Tenterden Street*, both sides, from the westerly kerbline of Back Manchester Road for a distance of 10 metres in a westerly direction.

The Order contains exemptions to permit waiting for the purpose of boarding or alighting, loading and unloading, building operations and work on or under the length of road. Disabled person's vehicles displaying the relevant disabled person's badge may wait for up to two hours return prohibited within one hour.

A copy of the Order which comes into operation on 12th February 1979, and a map showing the road to which it relates may be inspected between 9 a.m. and 4.30 p.m. on Mondays to Fridays at:

(a) The County Secretary's Office, County Hall, (Mins-hull Street entrance), Piccadilly Gardens, Manchester; or

Any person who wishes to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds
