The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Subject to the provisions of and the exemptions referred to in Section 9 of the Act of 1968, any person who acquires or sells any solid fuel other than authorised fuel for use of sens any solid the other than authorised ther for use in the Smoke Control Area will be guilty of an offence and liable to a fine not exceeding £100.

If confirmed, the Order will not come into operation before 1st November 1979.
