

YORK CITY COUNCIL

The City of York (Off Street Parking Places) (Amendment) Order 1979

Notice is hereby given that the York City Council proposes to make an Order under Section 31 (1) and 84D (1) of the Road Traffic Regulation Act 1967 as amended the effect of which will be as follows:

- (a) to convert the Foss Bank, Nunnery Lane and St. Johns Car Parks from barrier control to 'pay and display';
- (b) to convert the Gillygate Car Park to barrier controlled operation—this Car Park will also replace the St. Johns Car Park as the Car Park available for season ticket holders only on Monday-

Friday during the summer months;

- (c) to impose no charge in respect of any period of waiting which falls between the hours 8 p.m.-8 a.m. in barrier controlled car parks and 6.30 p.m.-8.30 a.m. in 'pay and display' car parks—the different in the two periods is necessary because of the different methods of operation of these two kinds of car park.

The charges for the use of those car parks, and the time limits and classes of vehicle for which they are available are as follows:—

 - 8.30 a.m.-6.30 p.m.—Sunday—15p
 - 8 p.m.-8 a.m. free
 - Outside the above hours—15p
- Short Stay Pay and Display Car Parks
 - 8.30 a.m.-6.30 p.m.—Monday-Saturday—as for Short Stay barrier controlled car parks
 - 8.30 a.m.-6.30 p.m.—Sunday—10p
 - 6.30 p.m.-8.30 a.m.—any day—free
- Long Stay Barrier Controlled Car Parks
 - During the winter period (October-March) 8 a.m. 8 p.m.—15p
