

The Orders will come into force on 26th January 1979 and the effect of the Orders will be as follows:

*Order**Effect of Order*

1. The Borough of Ellesmere Port and Neston (York Road) (Prohibition of Waiting) Order 1973.
  - (a) To prohibit, with certain exceptions, the waiting of vehicles at any time in the lengths of roads specified in Schedule 1 to this Notice.
  - (b) To revoke the Borough of Ellesmere Port (Market Street and Other Roads) (Prohibition and Restriction of Waiting) Order 1970 in so far as it relates to that length of York Road described in Schedule 1 to this Notice.
2. The Borough of Ellesmere Port and Neston (Mill Lane, Little Stanney) (Prohibition of Waiting) Order 1978.
  - To prohibit, with certain exceptions, the waiting of vehicles at any time in the length of road specified in Schedule 2 to this Notice.

The exceptions referred to will, in respect of the two Orders, permit a vehicle to wait for the purposes of picking up or setting down of passengers, loading or unloading of goods, building or demolition works, roadworks, the maintenance of essential services, emergency services, post office services, the removal of obstructions to traffic and statutory powers and duties. Disabled persons vehicles will also be permitted to wait in the prohibited areas for periods not exceeding 2 hours at any one time with an interval of 1 hour between any two periods.

Copies of the Orders and the relevant maps may be inspected at the offices of the undersigned during normal office hours.

Any person who desires to question the validity of the Orders or of any provision contained therein on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1967 (amended as aforesaid) or on the ground that any requirement of the Act or of any regulation made thereunder has not been complied with in relation to the Orders may within six weeks from 22nd January 1979 make application for the purpose to the High Court.

## SCHEDULE 1

*Lengths of roads in the Borough of Ellesmere Port and Neston*

- (a) Both sides of York Road from its junction with Wellington Road to its junction with the access road to the Wellington Road Market and Lewis's Saverstore.
- (b) Both sides of the access road referred to in (a) above which said road runs parallel to Wellington Road and extends from the entrance on the north-easterly side of Wellington Road Market for a distance of 128 yards or thereabouts to a point adjacent to the north-easterly boundary of the service area of Lewis's Saverstore.

## SCHEDULE 2

*Length of road in the Borough of Ellesmere Port and Neston*

Both sides of Mill Lane, Little Stanney from its junction with the Motorway roundabout up to and including the canal bridge for a distance of 267 yards approximately (243 metres).

*The County of Humberside (Kingston-upon-Hull) (Blackfriargate) (One Way Traffic) (Revocation) Order 1979*

*The Lancashire County Council Danes House Road Canal Bridge (L.C.C. No. 4633) Weight Restriction (Revocation) Order 1979.*

## LINCOLNSHIRE COUNTY COUNCIL

*The Lincolnshire County Council (Allenby's Chase, Sutton Bridge) (Prohibition of Waiting) Order 1979*
