The City of York (Acomb Traffic Scheme) (No. 2) Order 1979

Notice is hereby given that the York City Council pursuant to arrangements made with the North Yorkshire County Council under section 101 of the Local Government Act 1972 in exercise of the County Council's powers under the Road Traffic Regulation Act 1967 as amended, propose to vary the proposals previously advertised for Front Street, Acomb between its junctions with Green Lane and York Road. (c) 60 minute limited waiting (with no return within 1 hour) 8 a.m. to 6 p.m. Monday to Saturday in Front Street on its south side from a point 35 metres to the east of the eastern kerbline of Green Lane for a distance of 60 metres in an easterly direction.

The other restrictions already advertised as part of the No. 2 Order are unaltered. Subject to the consideration of any objections to (a), (b) or (c) above it is proposed to introduce the amended proposals on 17th April 1979 when the current experimental scheme expires. The position will be reviewed after the amended scheme has been in operation for 12 months.

A copy of a draft Order, a statement of the reasons for introducing the additional restrictions and a map showing the lengths of road affected may be seen at my office during normal business hours.

Objections to the proposals outlined in (a), (b) or (c) above should be sent to me in writing by 6th March 1979 and should specify the grounds on which they are made.
