*The Trunk Road (Tremond Road, Llandrindod Wells)
(Prohibition of Waiting) Order 197*

Notice is hereby given that a public inquiry will be held by Mr. J. Fleming, O.B.E., F.R.I.C.S., F.I.H.M., M.B.I.M., at the Council Chambers, Powys County Hall, Llandrindod Wells on 4th and 5th April 1979 commencing at 10.30 a.m., to consider the proposal of the Secretary of State for Wales to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, the effect of which would be to prohibit waiting, of vehicles at any time on the sides of the length of trunk road specified in the Schedule to this notice.
