#### *The County of Devon (Cockington Lane, Paignton) (Weight Restriction) Order 1979*

Notice is hereby given that the Devon County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended.

When the proposed Order comes into effect, you will not be allowed to drive any vehicle the unladen weight of which exceeds three tons in Cockington Lane between its junction with Great Headland Crescent and its junction with Upper Headland Park Road at Paignton in the Borough of Torbay.

#### DYFED COUNTY COUNCIL

#### *The County of Dyfed (Dolwen Beach Road, Aberporth) (Seasonal Prohibition of Waiting) Order 1979*

Notice is hereby given that the Dyfed County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of this Order will be:
