## ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester (40 m.p.h. Speed Limit) (No. 1) Order, 1979*  
*Roman Road, Hereford*

Notice is hereby given that on 9th February 1979, the County Council of Hereford and Worcester made an Order under section 74 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974, and of all other enabling powers, and with the consent of the Department of Transport, which will impose a 40 m.p.h. speed limit from the eastern side of the A49/A4103 roundabout, eastwards on the A4103 Roman Road, to a point 54 metres east of its junction with Old School Lane, a distance of 590 metres (645 yards).

The Order will come into operation on 19th February 1979.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, between 9.30 a.m. to 12.30 p.m. and 2 p.m. to 4 p.m. from Monday to Friday inclusive.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirement of that section or of section 84A, 84B or 84C of the Act of 1967 or of any Regulations made under the said section 84C has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made (such date stated in this notice) make application for the purpose to the High Court.

## ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester (Court Row, Upton upon Severn) (Restriction of Waiting) Order 1979*

The County Council of Hereford and Worcester propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, and of all other enabling powers, the effect of which will be to prohibit the waiting of vehicles from Monday to Saturday 8 a.m. to 6 p.m. on:

- (a) the western side of Court Row, Upton upon Severn, from its junction with Court Street for a distance of 42 metres (138 feet) in a southerly direction.
- (b) the eastern side of Court Row, Upton upon Severn from its junction with Court Street for a distance of 39 metres (130 feet) in a southerly direction.

Waiting by vehicles of the under-mentioned classes or for the under-mentioned purposes are exempted from the provisions of the Order:

1. to enable persons to board or alight;
2. to enable goods to be loaded and unloaded;
3. vehicles in use by the Post Office;
4. to enable certain essential works to be carried out or in pursuance of statutory powers or duties;
5. for the collection or delivery of furniture or effects with Police consent;
6. disabled persons' vehicles displaying a badge issued under the Local Authority's Orange Badge Scheme;
7. for fire brigade, ambulance and police purposes.

A copy of the draft Order and map showing the lengths of road affected and a copy of the County Council's Statement of Reasons for proposing to make the Order can be inspected at the offices of the Malvern Hills District Council, Portland House, Church Street, Malvern and at the Record Office, Shirehall, Worcester from Monday to Friday 9.30 a.m. to 12.30 p.m. and 2 p.m. to 4 p.m.

## HERTFORDSHIRE COUNTY COUNCIL

*The County of Hertford (A411 Sparrows Herne, Bushey) (Restriction of Waiting) Order 1979*

Notice is hereby given that the Hertfordshire County Council in exercise of their powers under section 1 of the Road Traffic Regulation Act 1967, as amended, propose to make an Order restricting waiting between the hours of 8.30 a.m. to 6.30 p.m. Mondays to Saturdays inclusive, on the following lengths of Sparrows Herne, Bushey.

*North side*, from a point 13 metres east of the centre line of the junction with Claybury eastwards for a distance of 155 metres.

*South side*, from a point 13 metres east of the centre line of the junction with Claybury to the eastern boundary of 37 Sparrows Herne, a distance eastwards of approximately 111 metres.

A copy of the draft Order and a map showing the road affected, together with a statement of reasons for the proposal, may be inspected at the offices of the Hertsmere Borough Council, Civic Centre, Borehamwood, and at Room 204, County Hall, Hertford during normal office hours.

## ISLE OF WIGHT COUNTY COUNCIL

*The Isle of Wight County Council (Various Streets, St. Helens, IW) (Traffic Regulation) Order No. 1 1979*

Notice is hereby given that the County Council of Isle of Wight in exercise of their powers under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended and after consultation with the Chief Officer of Police, propose to make an Order the effect of which will be as follows:

1. To revoke The County Council of Isle of Wight (Various Streets, St. Helens) (Traffic Regulation) Order No. 1 1976.
2. To re-enact the provisions contained in the above Order subject to the following amendment:

To prohibit the waiting of vehicle at any time in the following length of road:

*Upper Green Road* on south side from a point 45 feet east of its junction with Vine Road to its junction with Mill Road.

The Order is designed to reduce congestion and delay in the said roads and to facilitate the free flow of traffic generally in the promotion of road safety.

The Order contains exemption clauses to permit the loading and unloading of goods.

A copy of the draft Order, this notice and relevant plan may be inspected between normal office hours at the Reception Desk, County Hall, Newport, Isle of Wight, during the objection period. If you wish to object to the proposed restrictions contained in this notice you should send the grounds for your objection, in writing, to the undersigned not later than 12 noon on Monday, 12th March 1979.
