to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait elsewhere; or to enable a vehicle to wait in any case where the person in control of the vehicle is required by law to stop, is obliged to stop in order to avoid an accident, or is prevented from proceeding by aircumstance causide his control by circumstances outside his control.

# The Trunk Road (A1(M) Hertfordshire) (Temporary Prohibition of Traffic) Order 1979

Notice is hereby given that the Secretary of State for Transport has made an Order on the London-Edinburgh-Thurso Trunk Road (A1(M)) in the County of Hertfordshire.

The Order, which has been made to enable works to be carried out, will be in operation, when the appropriate signs are erected, from 23rd February 1979 until such time as the works have been completed. It is envisaged that, weather permitting, the works will last approximately six weeks.

The effect of the Order will be to close various lanes of both carriageways of the Trunk Road between Marker Post 49.6 and Marker Post 56.7. This length of Trunk Road extends from south of Coreys Mill Roundabout (A602 Junction) to north of Letchworth Gate Roundabout (A6141 Junction).

Whilst the Order is in operation there will be some diversion of traffic involving use of the verge (hardshoulder), transfer of northbound traffic to the southbound carriage-way and transfer of southbound traffic to the northbound carriageway.

During the period of closure overtaking will be prohibited on those lengths of the carriageway over which diverted traffic is required to proceed.
