

(d) to stop up private means of access to premises ;
and
(e) to provide a new means of access to premises,
all at Synod Inn aforesaid, and providing for the transfer of the said new highway to the County Council of Dyfed as from the date on which he notifies the Council that the new highway has been completed.

The Trunk Roads (Various Roads, Aberystwyth) (Prohibition and Restriction of Waiting) (Variation) Order 1979

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974. The effect of the proposed Order will be to vary the existing traffic order, which imposes waiting restrictions on the trunk roads in Aberystwyth, so that limited waiting on Mondays to Saturdays between 8 a.m. and 6 p.m. for one hour in any period of two hours will be allowed on the sides of road specified in the Schedule to this notice.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle ; to enable goods to be loaded on to or unloaded from the vehicle ; to enable a vehicle to be used in connection with any building, industrial or demolition operation ; the removal of any obstruction to traffic, the maintenance of the road or the services therein or to enable the vehicle to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties.

Exceptions will also be provided in the Order to allow vehicles bearing a disabled person's badge to wait for as long as may be necessary on the sides of road specified in the Schedule to this notice.

A copy of the proposed Order, a copy of the Order to be varied, together with a plan and statement of reasons for making the Order may be seen during normal office hours at the offices of the Ceredigion District Council, Town Hall, Aberystwyth.
