(D) The No. 2 Westbound Slip Road shall mean the road running south-westwards and thereafter westwards from its junction with the south-western end of Risle Butt Road to its junction with Marine Parade.

(E) The Marina Entrance Road shall mean the road running southwards and thereafter south-eastwards from its junction with the No. 2 Westbound Slip Road to a point 50 feet east of the centre of the Marina

Roundabout No. 1.

(F) The Marina Exit Road shall mean the road running north-westwards, northwards and thereafter eastwards from a point 50 feet east of the centre of the Marina Roundabout No. 1 to its junctions with the southwestern end of Rifle Butt Road and the No. 2 Westbound Slip Road.

(G) The Marina Roundabout No. 1 shall mean that roundabout the distance of the centre of which is 1,114.5 feet from the southern end of the Marina Entrance Road Tunnel under the A259, measured along the off side carriageway edge line of the Marina

Entrance Road.

3. When the Orders come into effect, waiting will be prohibited at all times as follows:

(a) in Arundel Road, from its junction with Marine Parade, northwards for a distance of 45 feet;
(b) in the Eastbound Slip Road;
(c) in Lewes Crescent (eastern side) from its junction

with Marine Parade, northwards for a distance of 45

(d) in the Marina Entrance Road;

- (e) in the Marina Exit Road;
 (f) in Marine Parade, from a point 45 feet west of Lewes
 Crescent (eastern side), eastwards to its junction with Marine Drive
- (g) in Marine Drive, from its junction with Marine Parade, eastwards to a point 1,190 feet east of the western kerb-line of the Eastbound Slip Road;

(h) in The No. 1 Westbound Slip Road;
(i) in The No. 2 Westbound Slip Road; and
(j) in Rifle Butt Road, from a point 180 feet south of its junction with Roedean Road, to its junctions with the No. 2 Westbound Slip Road and the Marina Exit Road.

The existing prohibition and restriction of waiting (if any) in force at present on the above-mentioned lengths of road, will be revoked.

4. Exceptions to paragraph 3 will permit waiting for the purposes of:

(a) picking up and setting down of passengers;(b) loading and unloading goods; and where necessary, in connection with:

- (c) the maintenance of the roads; and also
 (d) the maintenance for the supply of gas, water, electricity and of any telegraphic line; and
 (e) disabled persons' vehicles bearing the appropriate disabled person's badge, which will be allowed to wait for periods of up to two hours, return prohibited within

Full details of these proposals are in the draft Orders, which together with a map showing the roads affected and a statement of the Council's reasons for proposing to make the Orders, may be examined at the Equiry Office, Town Hall, Brighton, between the hours of 9 a.m. and 4 p.m. on Mondays to Fridays.
