

the north of the farm buildings turning south-easterly through the farmyard to Point B. It then turns north-eastwards across a stream into O.S. parcel No. 4638 and proceeds through a hedgebank and across O.S. parcel No. 4349 to Point D, to be diverted to a line that commences at Point A on the boundary of the Parishes of Moretonhampstead and North Bovey and proceeds north-easterly along a track following the north-eastern hedgebank of O.S. parcel No. 2900 through a gate and across O.S. parcel Nos. 3816 and 4820, turning north-westwards passing to the north of farm buildings to Point C. The path then turns and follows a northerly direction through O.S. parcel No. 4638 across a stile and through O.S. parcel No. 4349 along the eastern boundary hedgebank of that field to Point D.

##### *The Devon County Council (Public Path Diversion Order) Bovey Tracey Footpath No. 19*

Notice is hereby given that the above-named Order, made on 6th February 1979, is about to be submitted to the Secretary of State for the Environment to be confirmed as an unopposed Order by the Devon County Council.

The effect of the Order, if confirmed without modification, will be to divert two lengths of Footpath No. 19 Bovey Tracey. The first section commences at Point C on the map annexed to the Order and follows a track in parcel No. 3377 in a south-easterly direction for 35 metres to Point G where it changes direction to head north-eastwards for 60 metres through the Shapton Farmyard to Point D, which will be diverted to a line that commences at Point C and follows a north-east direction over a stile into parcel No. 2887 for 60 metres along a fence after which it changes to a south-westerly direction for 20 metres to Point D.

The second section commences at Point A, on the map annexed to the Order in O.S. parcel No. 4294 and heads in a generally eastward direction through O.S. parcels 4593 and 5092 for 150 metres to Point F. Curving north-westward through O.S. parcel 5595 into O.S. parcel 6289 the path then curves south-westward to enter O.S. parcel 7088 after 140 metres. From here the path follows the eastern side of the hedgebank in a southerly direction continuing into O.S. parcel 8887 along the same side of the hedgebank for 200 metres to Point B. This will be diverted to a line that commences at Point A in parcel No. 4294 and curves around following the hedgebank for 25 metres crossing parcel No. 4593 before going into parcel No. 2487 where it changes direction. It heads in an easterly direction for 135 metres along the south side of the fence into parcel No. 4787 and continues along this line, joins a track and meets the original line at Point F. It then changes direction with the track heading in a south-easterly direction for 50 metres then again in an easterly direction into parcel No. 6289 for 25 metres. It then leaves the track and runs once more in a south-easterly direction crossing the new forest ride and continues in this direction for 75 metres until it crosses into parcel No. 7475 where it runs along the eastern side of the hedgebank for another 150 metres. It then crosses into parcel No. 8568 and changes direction at Point E following the eastern side of the hedgebank for 110 metres in a north-easterly direction until it joins the original line at Point B, in parcel No. 8887.

##### *Public Path Diversion Order Lustleigh Footpath No. 15*

Notice is hereby given that the above-named Order, made on 6th February 1979, is about to be submitted to the Secretary of State for the Environment to be confirmed as an unopposed Order by the Devon County Council.

The effect of the Order, if confirmed without modification, will be to divert that length of Footpath No. 15 Lustleigh that commences at point A on the map annexed to the Order in the Nature Conservancy Woodland, parcel No. 4107 and crosses a hedgebank into parcel No. 6313 and follows the southern side of the hedgebank of that parcel for 200 metres to cross another hedgebank into parcel No. 8318 and again runs on the southern side of the hedgebank for 175 metres to a gate at point B, leading into unclassified County Road 1122, to a line that proceeds through a hedgebank into parcel No. 6622 from point A in parcel No. 4107 and runs along the northern side of the southern perimeter in that parcel of 375 metres to point C. At point C it passes southwards through a hedgebank into parcel No. 8318 to join the original line at point B, the gate leading into unclassified road 1122.
