on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order he may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 7 of the Act within 6 weeks from 23rd February 1979, make an application for the surrous 23rd February 1979, make an application for the purpose to the High Court.
