Prohibition and Restriction of Waiting) Order 197

Notice is hereby given that on 20th February 1979 the County Council of Avon made an Order under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended, the effect of which is:

PETERBOROUGH CITY COUNCIL
THE CITY OF PETERBOROUGH
(WERRINGTON) AREA*(Weight Restriction) Order 1979*

Notice is hereby given that pursuant to arrangements made with the Cambridgeshire County Council under Section 101 of the Local Government Act 1972, the Council of the City of Peterborough proposes to make the above named Order under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 (as amended).

Problems have been encountered in respect of the passage of heavy lorries through part of the Werrington Conservation Area. The Lincoln Primary Road, which is nearing completion, provides a first class by-pass to the Werrington area and eliminates the need for through movement and the City Council therefore intends to impose a weight restriction on the lengths of road mentioned below.

The effect of the proposed Order is to prohibit the driving of vehicles, with an unladen weight or more than 3 tons on the following roads:—
