Notice is hereby given that the Central Lancashire New Town Development Corporation ("the Corporation") on 23rd March 1979, made the Central Lancashire Development Corporation No. 38 (Plungington) Compulsory Purchase Order 1979 under section 7(1)(a) of the New Towns Act 1965. They have submitted this Order to the Secretary of State for the Environment for confirmation and if confirmed this Order will authorise them to purpose compulsorily the land described below for the purpose of comprehensively restructuring the internal accommodation of certain of the dwellings and demolishing the remaining properties and integrating their sites into open space proposals at Plungington, Preston, Lancashire.

It is important, therefore, that any objection should include a full statement in writing of the grounds on which the objection is made, as the objector may have no further opportunity to make such a statement.
