TOWN AND COUNTRY PLANNING ACT, 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under Section 212 of the Town and Country Planning Act 1971 for extinguishing any rights which persons may have to use vehicles on the lengths of highway specified in Schedule 1 to this Notice.

The Order contains provisions for permitting the use of the lengths of highway referred to in Schedule 1 to this Notice by vehicles in the cases specified in Schedule 2 to this Notice.

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to the highway to which the Order relates shall be entitled to be compensated by the Torfaen Borough Council as the local planning authority in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.
