DEVON COUNTY COUNCIL

The County of Devon (Southside Street, The Barbican, Plymouth) (Prohibition of Waiting) Amendment Order 1979.

Notice is hereby given that on 30th May 1979 the Devon County Council made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended, the effect of which is:

- (a) To prohibit the waiting of vehicles at any time on parts of the north side of Southside Street eastwards from its junction with Citadel Ope and westwards from its junction with The Barbican.
- (b) To rescind the City of Plymouth (Southside Street) (Traffic Regulation) Order 1966 in relation to limited waiting on parts of the north side of Southside Street.

Exceptions are provided in the Order permitting waiting for the purposes of boarding and alighting, loading and unloading, building and demolition, roadworks and the maintenance of essential services. Exceptions are also provided for disabled persons' vehicles in accordance with the orange badge scheme.

A copy of the Order and a map showing the roads to which the Order relates may be inspected during normal office hours at the address given below.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order you may, within 6 weeks from 30th May 1979, apply to the High Court for this purpose.

The Order will come into force on 1st June 1979.

DEVON COUNTY COUNCIL

The County of Devon (Union Street, Plymouth) (Reserved Bus Lane) Order 1978

Notice is hereby given that on 30th May 1979 the Devon County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended.

When this Order comes into effect on 1st June 1979 no vehicles, except buses (as defined in the Order) and bicycles will be allowed to enter, proceed or wait in the nearside lane of the eastbound carriageway of Union Street between its junction with Western Approach and Derry's Cross Roundabout.

Exceptions are included in the Order which will permit certain vehicles to enter, proceed or wait in the bus lane for specified purposes.

The Order also makes it unlawful for goods to be loaded on to or unloaded from the vehicles in the bus lane except in certain circumstances.

A copy of the Order and a map showing the roads to which the Order relates may be inspected during normal office hours at the address given below.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order,

you may within 6 weeks from 30th May 1979, apply to the High Court for this purpose.

The County of Devon (New North Road, Exmouth) (Waiting Restrictions) Order 1979

Notice is hereby given that on 31st May 1979 the Devon County Council made an Order under sections 1, 84D and 84D (1) of the Road Traffic Regulation Act 1967, as amended. The Order will come into force on 4th June 1969 and the effect thereof will be to prohibit and limit the waiting of vehicles on the south side of New North Road, Exmouth, for those lengths of road more specifically set out in the Schedules to the Order and for those lengths of time set out therein. The usual exemptions will apply including those for disabled drivers.

The existing limited waiting restrictions on the south side of New North Road insofar as they are inconsistent with the Order are revoked.

A copy of the Order and a plan showing the lengths of road are available for inspection at Room 3.33, Area Secretary's Office, Civic Centre, Exeter, and at the East Devon District Council Offices, Town Hall, Exmouth, during normal office hours.

If you wish to question the validity of the Order or of any provisions therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended or on the grounds that any requirement of the Act or of any instrument made under the Act has not been complied with in relation to the Order, you may within 6 weeks of 31st May 1979, apply to the High Court for the purpose.
