NOTICE OF APPLICATION FOR COMBINED LICENCE TO OBSTRUCT OR IMPEDE THE FLOW OF AN INLAND WATER BY MEANS OF IMPOUNDING WORKS AND TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Thames Water Authority by L. H. Hunt Limited for a combined licence to obstruct or impede the flow of the Cobbins Brook by means of a weir at MR TL 4505 0397 to abstract 5 million gallons of water per annum from the said inland water at or near that point.

3A. When Variation Order No. 58 comes into effect waiting will be prohibited on

Holdenhurst Road

(i) At any time with exemption for Hackney Carriages on the north-western side from a point 86 metres (283ft) south-west of its junction with St. Paul's Road for a distance of 22 metres (72ft) in a south-westerly direction.

(ii) At any time from a point 108 metres (355ft) south-west of its junction with St. Paul's Road for a distance of 33 metres (108ft) in a south-westerly direction.

(iii) To one hour in any hour between 10 a.m. and 7 p.m. from a point 165 metres (540ft) south-west of its junction with St. Paul's Road for a distance of 22 metres (72ft) in a south-westerly direction.

3B. When Variation Order No. 74 comes into effect waiting will be prohibited at any time on the northern side of *Old Christchurch Road* from its junction with Madeira Road for a distance of 21 metres (70ft) in a westerly direction with exemption for taxis.

3C. When Variation Order No. 75 comes into effect:-

(i) *Christchurch Road*

(a) Waiting will be prohibited at any time on the north-western side from a point 32 metres (105ft) north-east of its junction with Waltham Road in a north-easterly direction to cover the south-western end of the lay-by fronting 1102-1114 Christchurch Road.

(b) Waiting will be prohibited at any time on the north-eastern side of the lay-by fronting 1102-1114 Christchurch Road to its junction with Holdenhurst Avenue.

(c) Waiting will be limited to $\frac{1}{2}$ hour in any hour between 10 a.m. and 7 p.m. on the lay-by fronting 1102-1114 Christchurch Road.

(ii) *Hambledon Road*

Waiting will be prohibited at any time on both sides from its junction with Holdenhurst Avenue for a distance of 9 metres (30ft) in a north-westerly direction.

(iii) *Holdenhurst Avenue*

Waiting will be prohibited at any time on both sides from its junction with Christchurch Road in a north-easterly direction to a point 9 metres (30ft) north-east of its junction with Hambledon Road including the lay-by fronting the closed section of Hambledon Road.

(iv) *Charminster Road*

Waiting will be prohibited between 7 p.m. and 4 a.m. with exemption for Hackney Carriages on the north-western side from a point 19 metres (63ft) north-east of its junction with Shelbourne Road for a distance of 22 metres (72ft) in a south-westerly direction.

(v) *Columbia Road*

Waiting will be prohibited at any time on the southern side from a point opposite the western boundary of Number 183 Columbia Road in a westerly direction to its junction with Talbot Rise.

(vi) *Francis Avenue Cul-de-sac Section Adjacent to Ringwood Road*

- (a) Waiting will be prohibited at any time on the north-eastern side from its junction with the main arm of Francis Avenue for a distance of 43 metres (140ft) in an easterly direction.
- (b) Waiting will be prohibited at any time from its south-eastern extremity for a distance of 9 metres (30ft) in a north-westerly direction.
- (c) Waiting will be prohibited at any time on the whole length of the south-western side.

3D. When Variation Order No. 76 comes into effect waiting will be prohibited between 8 a.m. and 10 p.m. on the northern side of *Holdenhurst Road* from a point 55 metres (180ft) west of *Ashley Road* for a distance of 17 metres (55ft) in a westerly direction.

4. The usual exceptions will apply to loading and unloading goods, picking up and setting down passengers and certain works.

*City of Norwich**Earlham Road—Proposed Amendment to Bus Lane*

Notice is hereby given that Norwich City Council propose to make permanent the experimental 'bus lane' in Earlham Road, together with the associated waiting and loading restrictions and, at the same time, amend the hours of operation by bringing forward the starting time to 7.30 a.m.

The proposal would be brought into effect by a Traffic Regulation Order, which would contain the following restrictions:—

- (a) All vehicles except 'buses or pedal cycles, would be prohibited from using the 'bus lane between the hours of 7.30 a.m. to 9.30 a.m. Mondays to Saturdays.
- (b) The waiting restrictions would prevent any vehicles from waiting within the lengths of the 'bus lane between the hours of 7.30 a.m. to 9.30 a.m. Mondays to Saturdays.

Loading or unloading would be prohibited likewise.

There would be exceptions to the waiting restrictions to allow a vehicle to pick up or set down passengers, and for the necessary waiting in connection with building operations, postal services, and the maintenance of roads and all mains services.

(Kirklees) (Traffic Regulation) (No. 13) Order 1977*

Notice is hereby given that the West Yorkshire Metropolitan County Council propose to make an Order under their powers in the Road Traffic Regulation Act 1967, as amended. Opencast Coal Act 1958

Notice is hereby given that the National Coal Board intend to submit an application entitled the Icehouse Application 1979 to the Secretary of State for an authorisation under Section 1 of the Opencast Coal Act 1958, to work coal by opencast operations or to cause or permit coal to be worked by such operations and for an order under Section 15 of that Act suspending a public right of way. Description of Land

The land which is about 90 acres (about 37 hectares) in extent is in the parish of Ripley in the District of Amber Valley in the County of Derby. It is situated to the north-east of Ripley about 1.5 kilometres north-west of Codnor and lies to the east of Nottingham Road, Ripley (A610) (but does not include the cricket or football grounds) to the west and north-west of the Codnorgate Industrial Estate to the south-west of Butterley Park and the south and south-east of Home Farm. It is bounded on the west

by Coach Road, Ripley.

The land is included in O.S. Sheet Nos. SK.4050, SK.4051, SK.4150 and SK.4151 (all 1962 Edition) Scale 1/2500.

Opencast Coal Act 1958

Notice is hereby given that the Secretary of State, in exercise of his powers under Section 15 of the Opencast Coal Act 1958, on 1st May 1979, made the Ryefield (Suspension of Public Rights of Way) Order 1979 suspending public rights of way with effect from 15th May 1979.
