WAGES COUNCILS ACT 1979

Corset Wages Council

The Corset Wages Council hereby gives notice of proposals for (1) increasing the statutory minimum remuneration set out in the Wages (Corset) Order 1979 (Order K(89)); and (2) the revocation of Order K(89).

The Wages Council intends that the revised provisions shall operate from 11th May 1979.

Particulars of the proposals are contained in the Wages Council's Notice K(91), copies of which may be obtained on application to the Secretary of the Wages Council at the address given below. The Wages Council will consider any written representation with respect to the proposals if made within 14 days from 5th June 1979. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notice of Proposals K(91).
