Present,

The QUEEN'S Most Excellent Majesty in Council

Whereas the Secretary of State for the Environment, after giving to the Incumbent and Churchwardens of the Parish of East Boldre with South Baddesley, in the County of Hampshire, ten days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act 1853 as amended by subsequent enactments, made a Representation to Her Majesty in Council that burials shall be discontinued forthwith in St. Paul's Churchyard, East Boldre, in the said Parish, shown hatched on the plan annexed hereto.

Provided that in the said Churchyard, in any of the three grave spaces in which no interment has heretofore taken place, the burial may be allowed of the body of any person


for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, Her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 10th day of July next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the *London Gazette*, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within the Parish affected by such Representation one month before the said 10th day of July.

## HOME OFFICE

Notice is hereby given that the Secretary of State for the Home Department has made an Order under section 12 of the Coroners (Amendment) Act 1926, for the alteration of coroners' districts in the county of Devon.

The Order provides that the existing North Devon, West Devon, Plymouth, Torbay, East Devon and South Devon coroners' districts shall be abolished and the area comprised by them formed into four new coroners' districts which shall be known as the North and West Devon, the Exeter and East Devon, the Torbay and South Devon and the Plymouth and South-West Devon coroners' districts.
