HIGHWAYS ACTS 1959 TO 1971

The A604 Girton-Godmanchester Trunk Road (Bar Hill-Godmanchester Section Side Roads) Supplementary Order 1979.

The Minister of Transport hereby gives notice that, in relation to the above-mentioned Trunk Road between Bar Hill and Godmanchester and the new Trunk Road to be constructed by him at Fenstanton in the county of Cambridgeshire, he has made under section 9 of the Highways Act 1959 an Order, the effect of which is:

- (a) to authorise him:
 - (i) to improve, raise, lower or otherwise alter highways,
 - (ii) to stop up highways,
 - (iii) to construct new highways,
 - (iv) to stop up private means of access to premises, and
 - (v) to provide new means of access to premises, all between Bar Hill and Godmanchester aforesaid; and or in the vicinity of the route of the above-mentioned new trunk road; and
- (b) to provide for the transfer of each of the said new highways to the County Council of Cambridgeshire as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.
