WEST SUSSEX COUNTY COUNCIL

The County Council of West Sussex (Chichester: Ring Road (A286)) (30 m.p.h. Speed Limit) Order 1979

Notice is hereby given that the West Sussex County Council propose to make an Order under sections 72 (3), 73 (1) and 74 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and with the consent of the Secretary of State for Transport, the effect of which will be to introduce a 30 m.p.h. speed limit in the following roads in Chichester:

Churchside, Northgate, Oaklands Way, New Park Road, The Needlemakers, Market Road, Orchard Street, Southgate Circulatory System (Basin Road, The Link Road, Southgate and Market Avenue), St. Paul's Road—from Northgate north-westwards to Churchside, St. Pancras—from Eastgate Square north-eastwards to The Needlemakers, The Horner—from Eastgate Square eastwards to The Needlemakers and Market Avenue—from Market Road westwards to Basin Road.

A copy of the draft Order, a plan showing the affected roads and a statement of the County Council's reasons for proposing to make the Order may be inspected at the County Hall, Chichester, during normal office hours and at the Public Library, Tower Street, Chichester, during normal library opening hours. Library staff will not be in a position to answer questions on the proposal and any enquiries should be addressed to the undersigned.

Objections to the proposal together with the grounds on which they are made must be sent in writing to the undersigned by 5th July 1979.

WARWICKSHIRE COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT 1967—AS AMENDED

The Warwickshire County Council (Arbury Road, Nuneaton) (Prohibition of Waiting) Order 1979

Notice is hereby given that on 1st June 1979 the Warwickshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit the waiting of vehicles (except under the direction or with the permission of a police constable in uniform or a traffic warden) at all times on the length of road specified in the Schedule to this notice.

The Order will come into force on Monday, 11th June 1979.

Exceptions will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the Order together with a map showing the road affected may be inspected at the County Secretary's Department, Shire Hall, Warwick on Mondays to Fridays, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds

that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 1st June 1979, apply to the High Court for this purpose.

Arbury Road, Nuneaton, north side, from a point 36.6 metres east of its junction with Grove Road to its junction with Heath End Road (this replaces the existing unilateral waiting, and unrestricted waiting will be allowed on the south side of this length).

WILTSHIRE COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT 1967

The County of Wiltshire (Various Roads, Westbury) (Prohibition and Restriction of Waiting and Prohibition of Entry) Order 1979.

Notice is hereby given that the Wiltshire County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967 as amended the effect of which will be to extend and to amend the existing waiting restrictions on roads in Westbury as follows:

(A) *To prohibit waiting at all times on the following lengths of road:*

- (1) *The Butts*, south-east side, from a point 100 metres north-east of its junction with Hospital Road in a north-easterly direction to a point adjacent to the boundary between Nos. 36 and 38 The Butts.
- (2) *Eden Vale Road*, both sides, from its junction with Station Road to a point 30 metres west of that junction.
- (3) *Laverton Road*
 - (a) North side, from its junction with Warminster Road to its junction with Leigh Road.
 - (b) South side, from its junction with Warminster Road for a distance of 40 metres in a westerly direction.
- (4) *Leigh Road*, north-west side, from a point 124 metres south-west of its junction with Warminster Road, in a south-westerly direction, to a point 15 metres south-west of its junction with Springfield Road.
- (5) *Newtown*, both sides, from a point 25 metres south-east of its junction with The Butts to a point 15 metres north-west of that junction.
- (6) *Park View Drive*, both sides, from its junction with Westbury Leigh to a point 10 metres south-east of that junction.
- (7) *Springfield Road*, both sides, from its junction with Leigh Road to a point 20 metres north-west of that junction.
- (8) *Station Road*
 - (a) South-west side, from a point 30 metres north-west of its junction with Eden Vale Road south-east to the northern end of the lay-by at the Police Station.
 - (b) North-east side, from a point 30 metres north-west of the junction with Meadow Lane to a point 50 metres south-east of that junction.
- (9) *Warminster Road*
 - (a) North-west side:
 - (i) from its junction with Laverton Road for a distance of 30 metres in a southerly direction;
 - (ii) from a point 80 metres south-west of its junction with Haynes Road for a distance of 10 metres in a south-westerly direction to the entrance to the car park.
 - (b) South-east side, from its junction with Orchard Road to a point 10 metres north-east of that junction (instead of limited waiting on this length).

(B) *To prohibit waiting between the hours of 8 a.m. and 6 p.m. on any day other than a Sunday on the following length of Warminster Road:*

- North-west side, from a point 46 metres south-west of its junction with Haynes Road to a point 80 metres south-west of that junction (instead of limited waiting on this length).

The existing Orders providing for restriction and prohibition of waiting on roads in Westbury are being revoked and re-enacted as appropriate in this new Order, together with additions and amendments referred to above.
