The effect of the Order, if confirmed without modification, will be to extinguish the public right of way described in the Second Schedule hereto and to create the alternative highways described in the Third Schedule hereto

If no representations or objections are duly made, or of any so made are withdrawn, the Durham County Council may, instead of submitting the Order to the Secretary of State for confirmation, themselves confirm the Order as an unopposed Order. If it is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

#### FIRST SCHEDULE

subject to control and other regulations). (c) Buildings specified in a direction by the Secretary

of State.

and requires that any building to which section 277A applies shall not be demolished without the consent of the Secretary of State.

Section 61A of the Town and Country Planning Act 1971 applies to all trees within a Conservation area other than trees included in Tree Preservation Orders and prohibits the cutting down, lopping, topping, uprooting, wilful damage or wilful destruction of trees, except with the consent of the local planning authority or where a tree is dangerous.

## Amlwch Port Conservation Area
