Notice is hereby given that on 4th June 1979 the Cornwall County Council made an Order under sections 72 and 73 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972, the effect of which is that the length of road specified in the Schedule hereto shall be subject to a speed limit of 30 m.p.h.

#### CORNWALL COUNTY COUNCIL

*The County of Cornwall (Polperro) (Restrictions on Waiting) Order 1979*

Notice is hereby given that the Cornwall County Council propose to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be:

(A) to prohibit the waiting of vehicles :

- (i) at any time in any of the lengths of road at Polperro specified in the First Schedule hereto ;
- (ii) between 9 a.m. and 9 p.m. daily from 1st March to 31st October (both dates inclusive) in each year in either of the lengths of road at Polperro specified in the Second Schedule hereto ;

Exceptions will be provided in the Order to allow a vehicle to wait for (a) periods not exceeding 2 hours (return prohibited within 1 hour) if the vehicle is a disabled persons vehicle displaying a disabled persons badge and a parking disc in accordance with the appropriate regulations, and (b) so long as may be necessary to allow a person to board or alight from the vehicle ; to enable goods to be loaded or unloaded ; to enable postal packets to be delivered or collected ; in connection with statutory powers or duties, building operations, the maintenance or improvement of the lengths of road or of the services therein ; to take in petrol, oil, water or air from a garage ; and in connection with a funeral ;

(B) to limit the waiting of vehicles, except the vehicles of disabled persons to 1 hour in any 4 hours between 9 a.m. and 6 p.m. daily from 1st November in any year to the last day of February in the following year in either of the lengths of road at Polperro specified in the Third Schedule hereto.

Exceptions will be provided in the Order as specified in (A) (b) above.

(C) to amend existing traffic regulation measures operating in Polperro as necessary to give effect to the foregoing.

Objections to these proposals, together with the grounds on which they are made, must be sent in writing to the undersigned by 9th July 1979.
