*The Dorset County Council (Bridleway 8, Lytchett Minster)  
Public Path Diversion Order 1979*

Notice is hereby given that on 6th June 1979 the Dorset County Council confirmed the above-named Order.

The effect of the Order, as confirmed is to stop up the section of Bridleway 8 Lytchett Minster running from a point approximately 25 metres north of the A35 Upton to Poole Road (marked A on the map contained in the Order) in a north-westerly direction to a point approximately 95 metres north of the same road (marked B on the said map).

At the same time an alternative highway is created running from a point approximately 25 metres north of the A35 Upton to Poole Road westwards to the proposed subway under road L (as the point marked D on the map contained in the Order). It then runs in a north and then north-westerly direction to a point on the access track to Ty-Coed cottages approximately 95 metres north of A35 road. This route is shown by bold black dashes on the map contained in the Order marked C-D-E.

##### *Notice of Designation of Conservation Area*

Notice is hereby given that Elmburidge Borough Council in pursuance of section 277 of the Town and Country Planning Act 1971, as amended by section 1 of the Town and Country Amenities Act 1974, has designated as a Conservation Area the area described below:

"An area including the whole of Whiteley Village, Hersham. The area is bounded to the west by the Seven Hills Road; to the north by Burwood Road for a distance of 2,000 feet; to the east by a fence for 1,600 feet, King's Drive for 1,700 feet and a fence for 2,350 feet; to the south by a fence for 1,700 feet, meeting Seven Hills Road 150 feet north of Convent Lane."

Under the provisions of the Town and Country Amenities Act 1974, it is now unlawful to demolish a building within the Conservation Area without first obtaining the consent of the appropriate authority, subject to certain minor exceptions.
