The Trunk Road (Watling Street, Gillingham) (Prohibition of Right-Hand Turns) Order 197

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 on the London-Canterbury-Dover trunk road A2 at Gillingham in the district of Gillingham, in the county of Kent.

The effect of the Order would be to prohibit vehicles proceeding along the length of road known as Watling Street, Gillingham from making a right-hand turn into Derby Road.

A copy of the Order, together with a plan illustrating the proposals and a statement explaining the Minister's reasons for proposing to make the Order, may be inspected during office hours at the offices of the Gillingham Borough Council, Municipal Buildings, Gillingham, Kent.
