

NATIONAL COAL BOARD

OPENCAST COAL ACT 1958

Notice is hereby given that the National Coal Board intend to submit an application entitled the Wernos Colliery Application 1979 to the Secretary of State for an authorisation under section 1 of the Opencast Coal Act 1958 to work coal by opencast operations or to cause or permit coal to be worked by such operations and for an Order under section 15 of that Act suspending public rights of way. The land which the National Coal Board require to occupy in this connection and the rights of way to which the application for the Order relates are described below.

A copy of the application and of the accompanying map may be seen between the hours of 9.30 a.m. and 5.30 p.m. on Mondays to Fridays inclusive at the Ammanford Regional Branch Library, Talgarth Road, Ammanford, Dyfed.

Any objection to the application must be made in writing to the Secretary of State, c/o Welsh Office (EP.2), Cathays Park, Cardiff CF1 3NQ, before 30th July 1979 and should state whether it is to the grant of the authorisation or to the making of the Order suspending public rights of way and the grounds of objection.

Description of Land

The land which is approximately 102 acres (41 hectares) in extent is situated in the Community of Llanedy in the Borough of Llanelli in the county of Dyfed. It lies about two kilometres south-west of Ammanford about three-quarters of a kilometre north-east of Tycroes, about two kilometres south-east of Saron and about three-quarters of a kilometre west of Pantyffynnon.

Description of Public Rights of Way

1. Footpath No. 34/3 in the Community of Llanedy which runs from its junction with footpath 34/1 at a point about 20 metres south-south-east of Wern-nos Farmstead in a south-easterly direction for about 78 metres and then in a general east-south-easterly direction for about 158 metres to terminate at its junction with footpath No. 34/5 referred to in paragraph 3 below.

2. Footpath No. 34/4 in the Community of Llanedy which runs from the said footpath No. 34/5 referred to in paragraph 3 below at a point about 246 metres south-east of the said Wern-nos Farmstead in a north-westerly direction for 175 metres to its termination at a point about 90 metres east of the said Farmhouse.

3. Part of footpath No. 34/5 in the Community of Llanedy which runs from the eastern end of Heol Brown, Tycroes, at a point about 34 metres north-east of the property known as No. 37 Heol Brown in an east-north-easterly direction then a general easterly direction for about 941 metres continuing in a southerly direction for about 54 metres to terminate a point about 10 metres immediately east of the dwelling known as No. 38 Mill Terrace, Pantyffynnon, being that part which extends from its commencement in an east-north-easterly then general easterly direction for 915 metres.

Notice is hereby given that the above-named Order, made on 13th June 1979, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed as an unopposed Order by the County Council of Isle of Wight.

The effect of the Order if confirmed without modifications, will be to divert the public right of way running from the south-eastern end of Seagrove Farm Road, Seaview, Isle of Wight, through Seagrove Manor Farm and thence

south-westwards to Public Path R68, Seaview aforesaid to a line running from the south-eastern end of Seagrove Farm Road, Seaview aforesaid along the boundary of the Seaview Football Ground and from there east-south-eastwards to the point where it meets that part of Public Bridleway R67 which is not being diverted.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Reception Desk, County Hall, Newport, Isle of Wight, between 9.30 a.m. and 4 p.m. on weekdays.

If no representations or objections are duly made or if any so made are withdrawn the County Council of Isle of Wight may instead of submitting the Order to the Secretary of State for the Environment themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
