## NOTICE OF PUBLIC PATH ORDER

*The Cumbria County Council (Footpath No. 132014 Harker, Stanwix Rural) Public Diversion Order 1979*

Notice is hereby given that the above-named Order made on 15th June 1979 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the Cumbria County Council.

The effect of the Order, if confirmed without modifications, will be to divert the public footpath running from the eastern end of Harker Park Road across field O.S. No. 1400 for approximately 410 metres to join the U.1080 road at a point approximately 20 metres south of Crosshill Cottage to a line running from the eastern end of Harker Park Road eastwards for approximately 10 metres then northwards and north-eastwards for approximately 470 metres along the boundary of field O.S. No. 1400 to join the U1080 road at the afore-mentioned point south of Crosshill Cottage.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the offices of the Clerk and Chief Executive at the Courts, Carlisle.

Any representation or objection with respect to the Order may be sent in writing to the undersigned to be received not later than 23rd July 1979, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn the Cumbria County Council may instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State for the Environment any representations and objections which have been duly made and not withdrawn will be sent with the Order.

*The Devon County Council (Footpath 1 Combe Martin) Diversion Order 1978*

Notice is hereby given that on 11th June 1979, the Devon County Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way running from a point north-eastwards of West Park Farm house in the Parish of Combe Martin in field Ordnance Survey No. 8158 on Ordnance Survey Sheet No. SS5746 for the said Parish which said point is approximately 317 metres west of the junction of the path with Park Lane and continues for an overall distance of approximately 320 metres south-westwards then southwards to the south side of West Park Farm house where it turns westwards and then northwards running between the buildings of West Park Farm to a point approximately 200 metres east of the Parish boundary between Combe Martin and Berrynarbor to a line running from the said point approximately 200 metres east of the Parish boundary and continuing eastwards for approximately 80 metres to the eastern boundary of field Ordnance Survey No. 6655 at which point a stile will be erected then continuing eastwards for a further distance of approximately 50 metres to the point first above described in field Ordnance Survey No. 8158.

A copy of the Order as confirmed and the map contained in it has been deposited and may be inspected free of charge at the Town Hall, High Street, Combe Martin and at Room 304, Civic Centre, Barnstaple between 9 a.m. and 4 p.m. on weekdays.

The Order becomes operative as from 10th August 1979, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation

made thereunder has not been complied with in relation to the Order he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 28th June 1979, make an application for the purpose to the High Court.

*Forest of Dean District Council (GRU 19) (Rudford) Public Path Diversion Order 1979*

Notice is hereby given that on 5th June 1979, the Forest of Dean District Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert the public right of way running from a point approximately 60 feet east of St. Mary's Church being point "C" on the map and running in a north-easterly direction for 120 feet and then in a north-westerly direction for 100 feet to point "A" on the map to a line running from a point approximately 27 feet east of St. Mary's Church being point "B" on the map running in a north-easterly direction for 100 feet, then for 50 feet in a north-westerly direction and then in a north-easterly direction for a further 32 feet to the said point "A" on the map.

The Order becomes operative as from 5th June 1979, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended or that any regulation made thereunder has not been complied with in relation to the Order he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 22nd June 1979, make an application for the purpose to the High Court.
