##### *The South Yorkshire County Council (Northumberland Road, Marlborough Road and Crookesmoor Road, Crookesmoor, Sheffield) (Prohibition and Restriction of Waiting) Order 19*

Notice is hereby given that the South Yorkshire County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19

to the Local Government Act, 1972 and Schedule 6 to the Road Traffic Act 1974.
