The Hackney (Prescribed Routes) (No. 1) Traffic Order 1979

The Hackney (Waiting and Loading Restriction) (Amendment No. 22) Order 1979

Notice is hereby given that the Greater London Council on 21st June 1979 made the above-mentioned Orders under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The effect of the Hackney (Prescribed Routes) (No. 1) Traffic Order 1979 will be to impose one-way working for vehicular traffic in:

(a) *Downs Park Road*, between its junction with St. Mark's Rise, the north-west to south-east arm, and a point 3 metres east of a point opposite the common boundary of Nos. 34 and 35 St. Mark's Rise; from west to east.

(b) *St. Mark's Rise*, the north-east to south-west arm; from north-east to south-west.

3. The one-way workings referred to in paragraph 2 above will not apply in respect of anything done:

(a) with the permission or at the direction of a police constable in uniform;

(b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

4. The general effect of the Hackney (Waiting and Loading Restriction) (Amendment No. 22) Order 1979 will be further to amend the Hackney (Waiting and Loading Restriction) Order 1977, so that

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited:

(i) between 7.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the length of street specified in Schedule 1 to this notice;

(ii) between 8 a.m. and 6.30 p.m. on Mondays to Fridays inclusive and between 8 a.m. and 1.30 p.m. on Saturdays in the length of street specified in Schedule 2 to this notice;

(b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited:

(i) between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the length of street referred to in sub-paragraph (a) (i) above;

(ii) between 11 a.m. and 6.30 p.m. on Mondays to Fridays inclusive and between 11 a.m. and 1.30 p.m. on Saturdays in the length of street referred to in sub-paragraph (a) (ii) above;

(c) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraph (a) above will be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Hackney Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, in the lengths of streets referred to in sub-paragraph (a) above will be prohibited;

(e) the existing prohibitions on waiting by vehicles, on the sale of goods and on advertising activities in the length of street specified in Schedule 3 to this notice, imposed by the Hackney (Waiting and Loading Restriction) Order 1977 will be revoked.

6. The prohibitions referred to in paragraph 4 (a) and (b) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply.
