1. An Order under section 9 of the Highways Act 1959 which will

(a) authorise him

(i) to improve, raise, lower or otherwise alter highways,

(ii) to construct new highways,

(iii) to construct a new highway for temporary purposes and to close the temporary new highway, when the existing highway for which it has been constructed as a diversion has been improved and is re-opened to traffic, and

(iv) to provide new means of access to premises all at Hawarden aforesaid, and
