This Court doth declare the dissolution of the above-named Company to have been void.

And it is ordered that the applicant do within 21 days from the date hereof deliver an office copy of this order to the Registrar of Companies.

And it is ordered that the applicant the said Ernest William Dennis Lowing personally do pay to the Registrar of Companies his costs of and incidental to this Motion.
