

- (e) to a vehicle being used in the service of a local authority or of a water authority in pursuance of statutory powers or duties ;
- (f) to a vehicle waiting while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait elsewhere ; and
- (g) to a vehicle waiting in any case where the person in control of it :
- (i) is required by law to stop ;
 - (ii) is obliged to stop in order to avoid an accident ;
- or
- (iii) is prevented from proceeding by circumstances outside his control.

Any person who desires to question the validity of, or of any provision contained in the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 28th November 1979, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
