NOTICE OF PUBLIC PATH ORDER TOWN AND COUNTRY PLANNING ACT 1971

High Street, Stone, Staffordshire

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by section 209 of the Town and Country Planning Act 1971 and all other powers enabling him in that behalf, proposes to make an Order the effect of which will be to divert that part of footpath No. 38 at Stone which runs from High Street, approximately 25 yards northwest of its junction with Stafford Street, for a distance of approximately 17 feet in a south westerly direction and to create an alternative highway in lieu which starting at that point and running for a distance of approximately 8 feet in a south easterly direction and then in a north easterly direction parallel to the existing path, for a distance of approximately 13 feet until it joins the existing footway to point D on the map approximately 5 feet south east of the south side of High Street. The lines and situations of the existing and proposed alternative highway are shown on the map annexed to the draft Order.

NOTICE OF PUBLIC PATH ORDER TOWN AND COUNTRY PLANNING ACT 1971

*Diversion of part of footpath No. 9 at Woodbury Lane,
North Juxta Kempsey in the Wychavon District of
the County of Hereford and Worcester*

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred on him by section 209 of the Town and Country Planning Act 1971, and all other powers enabling him in that behalf, proposes to make an Order the effect of which will be to divert that part of footpath No. 9 which runs from its junction with Woodbury Lane in a south south-easterly direction for a distance of approximately 100 yards on to a new line starting from a point on Woodbury Lane approximately 20 ft. south west of the existing junction and running parallel to the existing footpath for a distance of approximately 85 yards then turning south east for a distance of approximately 24 yards to rejoin the existing footpath. The lines and situations of the existing and proposed alternative footpath are shown on the map annexed to the draft Order.

TOWN AND COUNTRY PLANNING ACT 1971

The Minister of Transport hereby gives notice that on the application of the Walsall Metropolitan Borough Council, he proposes to make an Order under section 212 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on part of High Street, Darlston.

The proposed Order will contain provisions for permitting the use of that highway by vehicles being used:
