(A22 London-Eastbourne Road) Caterham (24 Hour Main Carriageway Clearway) Order 1980

(Fairfield Link Road and Lower Fairfield Road), Leatherhead (Restriction of Waiting) Amendment and Revocation Order 1979

Notice is hereby given that on Wednesday, 28th November 1979, the Surrey County Council made an Order under sections 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is—

(A) To restrict waiting Mondays to Saturdays, 8 a.m. - 6 p.m. as follows:

*Fairfield Link Road:* On both sides from its junction with Linden Road for its entire length in a north-westerly direction, a distance of approximately 37 metres on its north-eastern side and approximately 53 metres on its south-western side.

*Lower Fairfield Road:* On both sides from its junction with Fairfield Link Road (as described above) in a south-westerly direction to a line extending the boundary between Nos. 41 and 43 Lower Fairfield Road, a distance of approximately 11 metres on its north-western side and approximately 18 metres on its south-eastern side, and

(B) To rescind the "No Right Turn" regulation from Epsom Road into Linden Road.

The Order will come into operation on 10th December 1979.

If you wish to question the validity of the Order or of any provision in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from the date of this notice, apply to the High Court for this purpose.
