TOWN AND COUNTRY PLANNING ACT 1971
(Section 209 and 210)

Macclesfield Borough Council (Footpath No. 13—Carlisle Close, Mobberley) Public Path Stopping Up Order 1979

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 23rd November 1979 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Macclesfield Borough Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to extinguish the public right of way running from a point marked 'A' on the map accompanying the Order where it proceeds in a south westerly direction across proposed development north of Carlisle Close for a distance of 144 metres to reach point 'B' at the boundary of the site.

A copy of the Order and the map contained in it has been deposited at the Macclesfield Service Centre, Town Hall, Macclesfield, and also at the Knutsford Service Centre, Toft Road, Knutsford, and may be inspected free of charge during normal office hours 9 a.m.—5 p.m. (Friday 9 a.m. — 4.30 p.m.). The documents may also be inspected at the Public Libraries in Park Green, Macclesfield, and Brook Street, Knutsford, during normal opening hours.

Any representation or objection with respect to the Order should be sent in writing to the Macclesfield Borough Council, Stuart House, King Edward Street, Macclesfield, not later than 14th January 1980 and should state the grounds on which it is made.

If no representation or objection is duly made, or if any so made are withdrawn, the Macclesfield Borough Council may instead of submitting the Order to the Secretary of State for the Environment themselves confirm the Order as an unopposed order. If the Order is submitted to the Secretary of State for the Environment for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT 1971 SECTION 210

Macclesfield Borough Council (Footpath No. 17, Norfolk Farm, Withington) Public Path Diversion Order 1979

Notice is hereby given that on 7th December 1979, the Macclesfield Borough Council confirmed the above named-Order.

The effect of the Order as confirmed is to divert footpath No. 17 from a point marked 'A' on the map accompanying the Order where it proceeds in a north-easterly direction across land in the vicinity of Norfolk Farm then in a generally easterly direction to the junction with Nook Road to a re-aligned position where it would run in a north-westerly direction across field reference Nos. 6800 and 5131 for a distance of 360 metres, then northerly for a distance of 455 metres before continuing in a north-westerly direction for a further 30 metres. Thereafter the path continues in a northerly direction adjacent to Colt Hovel Wood for a distance of 140 metres, then south in a south-easterly direction along the northern boundary of Colt Hovel Wood to reach a point marked 'F'. From this point the path proceeds in a northerly then easterly direction to reach point 'H' before continuing again in a northerly direction for a distance of 110 metres to point 'J'. From this point the path continues in a predominantly easterly direction to the junction with Nook Road before continuing in a south-easterly direction for a distance of 528 metres to rejoin the existing terminal of Footpath No. 17 at a point 'A2'.

A copy of the confirmed Order and map contained in it has been deposited at the Macclesfield Service Centre, Town Hall, Macclesfield and may be inspected free of charge, during normal office hours 9 a.m.—5 p.m. (Friday 9 a.m.—4.30 p.m.) and also at the Wilmslow Service Centre, Council Offices, South Drive, Wilmslow, Knutsford Service Centre, Toft Road, Knutsford during the above-mentioned hours. The documents may also be inspected at the Public Libraries at Park Green, Macclesfield and Heyes Lane, Alderley Edge.

This Order becomes operative as from 17th December 1979 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the grounds that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under Section 217 and Schedule 20 of the Town and Country Planning Act 1971 within 6 weeks from 13th December 1979 make application for the purpose to the High Court.

The North Tyneside (Rake Lane, North Shields Footpath No. 6) Public Footpath Stopping-up Order 1979

Notice is hereby given that the above named Order (hereinafter referred to as "The Order") made on 3rd December 1979 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Council of the Borough of North Tyneside as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to extinguish the public right of way commencing at a point on Rake Lane, North Shields shown 'A' on the map contained in the Order to a point shown 'E' on the said map and create an alternative highway in lieu.
