Scheme for the establishment of crossings for foot passengers in the Borough of Thamesdown

Notice is hereby given that the Thamesdown Borough Council acting as Agents for the Wiltshire County Council, pursuant to an Agreement made under the provisions of Section 101 of the Local Government Act, 1972, have obtained the approval of the Secretary of State for Transport to a variation contained in the scheme for the establishment of crossings for foot passengers in the Borough of Thamesdown made by the said Thamesdown Borough Council on 9th July, 1975, and approved by the Secretary of State for the Environment on 27th August, 1975, that Pelican crossings be installed in the lengths of roads referred to in the Schedule hereto.

Maps showing the lengths of roads indicating the crossings may be inspected at the offices of the Director, Technical Services, Thamesdown Borough Council, Civic Offices, Swindon, during normal office hours.
