##### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT, 1971, SECTION 210  
*Council of The Borough of Harrogate (West Lane, Ripon)*  
*Public Path Diversion Order 1979*

Notice is hereby given that on the 12th December 1979 the Council of the Borough of Harrogate (hereinafter called "the Council") confirmed without modification the above-named Order. The effect of the Order as confirmed, is to divert that part of the existing path which commences at the south-eastern corner of 20 Quarry Road (Point B on the map attached to the Order) and goes west along the southern boundary of that property for approximately 100 feet to Point A and then turns south-west and crosses diagonally O.S. Field 7455 through Point G for approximately 560 feet to Point H where it joins an existing bridleway on the field boundary to a line running from the said Point B at the south-eastern corner of 20 Quarry Road in a south-easterly direction along the western side of a proposed estate road for approximately 60 feet to Point C where it turns south-westerly and runs along the northern side of the proposed estate road to Point D and then crosses the proposed estate road to Point E and then runs along the southern side of that proposed estate road to Point F being at the first informal turning head on the proposed estate road which it crosses and joins the existing path at Grid Ref. SE 3067 6948 being Point G on the map and a distance from Point C of 520 feet approximately.

A copy of the Confirmed Order and the map contained in it has been deposited at the Chief Executive's Office, Council Offices, Harrogate, and may be inspected free of charge at that office between the hours of 8.45 a.m. and 4.45 p.m. on Mondays to Fridays (except Christmas Eve, Christmas Day, Boxing Day and 1st January 1980).

This Order becomes operative as from the date on which it is certified by the Council that the diverted footpath has been completed to the satisfaction of the Director of Technical Services of the Council, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971 or on the grounds that any requirement of that Act of any Regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under Schedule 6 of the Town and Country Planning Act 1971 within six weeks from the date on which this Notice is first published, as required by the Town and Country Planning Act 1971, make application for the purpose to the High Court.

#### PETERBOROUGH CITY COUNCIL

TOWN AND COUNTRY PLANNING ACT 1971  
TOWN AND COUNTRY AMENITIES ACT 1974

*Conservation Areas—Peterborough City Council*

Notice is hereby given that the Peterborough City Council in pursuance of their powers under section 277 of the Town and Country Planning Act 1971 (as amended by section 1 of the Town and Country Amenities Act 1974) have designated as Conservation Areas the areas described in the Schedule below.

The purpose of these designations is to conserve and enhance the architectural and historic character of the areas and to ensure that special regard is paid to these qualities when proposals for developments are considered.

The main provisions of the Town and Country Amenities Act 1974 are that with certain exceptions no buildings within Conservation Areas, listed or unlisted, may be demolished without the consent of the City Council and that owners wishing

to fell or lop a tree must give notice to the City Council who then have six weeks to decide whether a Tree Preservation Order should be served.

Copies of the maps of the Conservation Areas can be inspected during normal office hours in the City Planning Department at 24 Church Street, Peterborough.

#### SCHEDULE

##### *Peakirk*

The Conservation Area covers all the properties and land to the west of St. Pega's Road and Deeping St. James Road from the paddock north-west of No. 26 St. Pega's Road to the field at the northern end of the village with the exception of No. 9 Rectory Lane and the allotment gardens. Also included are the War Memorial at the junction of Rectory Lane and St. Pega's Road, No. 1 St. Pega's Road, properties north of Newborough Road from No. 1 to No. 9 Newborough Road and properties east of the Deeping St. James Road from its junction with Newborough Road to the area of open space to the north of The Hermitage.

##### *Sutton*

The Conservation Area covers all the properties to the north of Nene Way from The Drift to the River Nene, including the land on the eastern bank of the river and the village pound, properties to the east of Manor Road from Manor Farm to Springfields, properties south of Graeme Road from High Trees to the dismantled railway line. Also included are all the properties and land between Lovers Lane and Manor Road including the dismantled railway line and old bridge crossing. To the west of Lovers Lane, St. Michael's Church, The Grange, surrounding land and outbuildings, together with a narrow belt of land adjacent to the stone wall, forming the western boundary of The Grange, which leads down to the River Nene.

*Tyne and Wear County Council Footpath No. 124 (Whickham)*  
*Public Path Diversion Order 1979.*

Notice is hereby given that the above-named Orders, made on 12th December 1979, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order by the Tyne and Wear County Council.

The effect of the Order, if confirmed without modifications, will be to divert the public right of way which runs from a point on Bridleway 123, 110 metres south of Riding Barns Farm near Fellside and runs in a southerly direction for 200 metres along the eastern side of a hedge and then for 220 metres across arable field. The path when diverted will run from a point on Bridleway 123 235 metres south of Riding Barns Farm in a southerly direction for 380 metres along the eastern side of a field boundary hedge then through a gap in the hedge and then for 210 metres along the western side of a field boundary fence to meet the existing path.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at my office between 8.30 a.m. to 4.30 p.m. on Mondays to Fridays and at Whickham Public Library, St. Mary's Garden, Whickham during usual opening hours.

Any representation or objection with respect to the Order may be sent in writing to me at the address below before 21st January 1980, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Tyne and Wear County Council may instead of submitting the Order to the Secretary of State themselves confirm the Order.

If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
