The London-Fishguard Trunk Road (A48) (Lydney Gloucestershire) (Prohibition of Waiting) Order 1980

The Minister of Transport hereby gives notice that he proposes to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974 on the London-Fishguard Trunk Road (A48) at Lydney in the District of the Forest of Dean in the County of Gloucestershire

The effect of the Order will be to impose a prohibition on waiting in that length of High Street which extends from its junction with the north eastern side of Church Road (where existing prohibition of waiting ends) to a point 30 metres south west of its junction with Templeway West.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or to alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, maintenance of the road or services therein. Exceptions will also be provided for disabled persons' badge holders and for a vehicle waiting upon the direction or with the permission of a police constable in uniform or of a traffic warden.
