Notice is hereby given that the Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by sections 11 (4) and 109 (6) of the Land Drainage Act 1976, has now made an order confirming a Scheme submitted to him by the Wessex Water Authority under section 11 (1) of the Land Drainage Act 1976, making provision for the abolition of the Lower Avon Internal Drainage District and the Drainage Board thereof.

The Order will become final and have effect as an Act of Parliament unless during the period ending with 23rd January 1980 a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial (as prescribed in Article 6 of the Land Drainage (River Authorities) General Regulations 1965 (S.I. 1965/443) as applied to Water Authorities by section 9 of the Water Act 1973) praying that the Order shall be subject to special parliamentary procedure.
