- (f) establishing a team Ministry for the area of the new benefice, in the diocese of Saint Edmundsbury and Ipswich.
- 19. (a) Creating a new benefice and parish of Tilney Saint Lawrence;
 - (b) altering the name of the benefice and parish of Tilney All Saints with Saint Lawrence;
 - (c) holding in plurality the benefice of Terrington Saint John and the new benefice of Tilney Saint Lawrence; and
 - (d) transferring part of the parish of Terrington Saint John to the parish of Terrington Saint Clement, in the diocese of Ely.

- 32. (a) Uniting the benefices of Kinnerley with Melverley; Knockin with Maesbrook;
 - (b) creating a new parish of Maesbrook out of the
 - existing parish of Knockin with Maesbrook; and (c) altering the name of the parish of Knockin with Maesbrook, in the diocese of Lichfield.

33. Uniting the benefices and parishes of Saint Leonard, Bilston; and Saint Mary, Bilston; in the diocese of Lichfield, and establishing a team ministry for the area of the new benefice.
