#### HIGHWAYS ACTS 1959 TO 1971

*The London-Birmingham Trunk Road (Closure of Access to Tring Road, Northchurch Side Roads) Order 19*

The Minister of Transport hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road at Northchurch in the county of Hertfordshire, to make under section 9 of the Highways Act 1959 an Order which will—
