# WIRRAL METROPOLITAN BOROUGH COUNCIL TRAFFIC REGULATION ORDERS

Notice is hereby given that on 11th December 1979, Wirral Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Merseyside in exercise of the powers of the said County Council, made the under-mentioned Orders under sections 1 (1), (2), (3), (31) and 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974:

The effect of the above Order is to increase the excess charge payable from £2 to £3 in the parking places specified in Schedule 1.

- Metropolitan Borough of Wirral (Parkside and Various Streets, Wallasey) (Prohibition of Waiting) Order 1979.

The effect of the above Orders will be to prohibit the waiting of vehicles at any time in the length and side of roads specified in Schedules 2 and 3.

Exceptions will be provided in the Orders to permit:

- (a) picking up and setting down of passengers;
- (b) loading and unloading of goods;
- (c) maintenance of roads;
- (d) supply of gas, electricity and water;
- (e) in pursuance of statutory powers and duties; and
- (f) disabled persons' parking.

The Orders will come into operation on 4th February 1980 and 3rd March, 1980 respectively and copies thereof and relevant maps may be seen at all reasonable hours at the Department of Administration & Legal Services (Room 22), Town Hall, Wallasey.

If you wish to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers conferred by the Act of 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Orders, you may within 6 weeks from 11th December 1979, apply to the High Court for this purpose.
