*The South Oxfordshire District Council Public Path (Tetsworth No. 8) Diversion Order 1979*

Notice is hereby given that on 10th December 1979 the South Oxfordshire District Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way running from a point south-west of Harlesford Farm in a south-westerly direction for 272 metres to a line running from a point south-west of Harlesford Farm in a south south-westerly direction for 192 metres to the footbridge and then in a south-westerly direction for 94 metres.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Sub-Post Office, Tetsworth at normal business hours and at the South Oxfordshire District Council Offices, London Road, Wheatley between the hours of 8.30 a.m. and 5 p.m. on any normal working day.

The Order becomes operative as from 13th January 1980, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 13th December 1979, make an application for the purpose to the High Court.

*West Sussex County Council (Crawley) Public Path (No. 352) Diversion Order 1979*

Notice is hereby given that the above-named Order, made on 30th November 1979 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the West Sussex County Council.

The effect of the Order, if confirmed without modification, will be to divert part of the public bridleway No. 352 at Lowfield Heath, Crawley, by stopping up the path commencing at a point on Church Road, immediately west of the British Island Airways building, extending generally eastwards along the road for approximately 550 feet, thence south-eastwards along the access track to Rowley Cottages for approximately 275 feet, to join the Brighton Road, and substituting for that path a new length of public bridleway, a minimum width of 9 feet, commencing at a point on Church Road, at the western end of the length of path to be stopped up, extending southwards for approximately 445 feet along a fenced track to the northern boundary of the Brighton Road, thence north-eastwards, running over a new bridge, for approximately 750 feet, to join the south-eastern end of the length of path to be stopped up.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Office of the County Secretary, County Hall, Chichester, and at the Office of the Borough Secretary, Crawley Borough Council, Town Hall, The Boulevard, Crawley between 10 a.m. and 5 p.m. on Mondays to Fridays inclusive and at the Crawley Branch Library, County Buildings, Crawley on Mondays to Saturdays.

Any representation or objection with respect to the Order may be sent in writing to the County Secretary, County Hall, Chichester, Sussex and should be received on or before 18th January 1980 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the West Sussex County Council may, instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
