The Trunk Road (Berkhampstead) (A41) (Prohibition and Restriction of Waiting) Order 19

The Minister of Transport proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 on the London-Birmingham Trunk Road (A41) in the District of Dacorum in the County of Hertfordshire.
The effect of the Order will be to:

- (a) prohibit waiting between the hours of 8.30 a.m. and 6.30 p.m. on any day other than a Sunday on any of the sides of road specified in Schedule 1;
- (b) prohibit waiting at any time on any day on any of the sides of road specified in Schedule 2;
- (c) revoke the Orders specified in Schedule 3.

Parking has been restricted on the trunk road (A41) at Berkhamsted since 1965. This Order adds further restrictions along the north eastern side of the trunk road (A41), limiting waiting between the hours of 8.30 a.m. and 6.30 p.m. on any day other than a Sunday from a point 11 metres north-west of the junction with Manor Street to a point 34 metres south-east

the junction with Manor Street to a point 34 metres south-east of the junction with Castle Street, and prohibiting waiting at any time from a point 15 metres north-west of the junction with Ravens Lane to a point 15 metres south-east of that junction.
